#### **Eligibility:-**

- 1. Good academic record with at least 55% marks (or an equivalent grade in a point scale wherever marks grading system is followed) in the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited Foreign University. (Note: Good Academic Record means at least 55% marks or equivalent grade under grading systems of evaluation in the degree level examination).
- **2.** Besides fulfilling the above qualification, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- 3. Notwithstanding anything contained in (i) and (ii) above, candidates, who are, or have been awarded a Ph.D. Degree in a accordance with the University Grant Commission (Minimum standards and procedure for award of Ph.D. Degree) Regulations 2009, shall be exempted from the requirement of minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor of equivalent positions in Universities/Colleges/Institutions.

(Note: For appointment on the posts of teachers/scientists, it would be a basic requirement for the candidate applying for the posts to hold/possess respective basic professional degree at the Under-graduate level).

**4.** NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.

#### **Terms & Conditions**

- 1. The period of contractual engagement shall be for a period of 06 (six) months and subsequent extension as per requirement and provisions of **The Birsa Agricultural University Act, 2000** & Statute or till regular appointment made by JPSC, whichever is earlier.
- 2. The Selected Candidates are liable to be posted/transferred to any of the concerned Colleges/Unit within the jurisdiction of the University.
- 3. The University reserves the right to modify the number of posts as per the requirement.
- 4. The University reserves the right to fill/not fill any position without assigning any reason.
- 5. The incumbent shall get a fixed consolidated remuneration of Rs. 75000/- per month.
- 6. Engagement will be purely on temporary basis and liable to be terminated with one month notice from either side.
- 7. The candidate must give one month advance notice before resigning, if not, then their last monthly remuneration will be withheld.
- 8. No T.A/D.A shall be payable to the selected candidates for joining the contractual engagement.
- 9. The candidates claiming reservation must submit attested caste certificate duly issued by competent authority (not below the rank of BDO/CO).

- 7. Through this advertisement, appointment will be made on contract basis for 6 months, after this it is proposed to be given only one extension of service for the next six months as per University rules on the basis of satisfactory performance.
