The maximum age limit for appointment by transfer on deputation (including short-term contract)/transfer shall not be exceeding 56 years as on the closing date of receipt of applications).

The officers selected for the posts will have the option to either draw his grade pay in the parent cadre plus deputation (duty allowance) or to draw the pay in the scale of pay of the deputation posts as may be fixed in accordance with the existing orders. The rate of deputation allowance will be regulated in terms of the Department of Personnel & Training's orders contained in their O.M. No.2/22(B)/2008-Estt.(Pay-II) dated 03.09.2008 and amended time to time.
